Online entries must be received by 11:59 p.m. on the last day of the Sweepstakes (Oct. 3, 2016) to be entered into the random drawing. Eligible mail-in entries must be postmarked by 11:59 p.m. on the last day of the Sweepstakes (Oct 5, 2016) and received by 11:59 p.m. Oct. 5, 2016 in order to qualify for the random drawing.
